

**ORDINANCE NO. 3, 2010**

AUTHORIZING AND DIRECTING THE AUDITOR TO TRANSFER FUNDS, AND TO PROVIDE ADDITIONAL APPROPRIATIONS AND AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ST. BERNARD, STATE OF OHIO:

Section 1. That the Auditor is hereby authorized and directed to transfer \$1,653,075.30 from the General Fund into the following funds:

Section 2. That the Auditor is hereby authorized and directed to provide additional appropriations to the following:

Section 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is that the above funds are needed to be available for payment of expenses not provided for previously. Therefore, this Ordinance shall take effect immediately by and upon its passage, and the approval of two-thirds of the members of said Council. However, this Ordinance shall take effect on the earliest date provided by law if approved by no more than the majority of members of Council, and in that event, the emergency provisions herein are set at naught.
