

## **RESIDENTIAL RENTAL PERMIT APPLICATION**

Chapter 1335.23 of the St. Bernard Property Maintenance Code requires that the owner of all household dwelling units utilized as rental property shall acquire an annual rental permit for such dwelling units.

Application and permit fees are to be submitted annually. An annual inspection of the dwelling units and premises is necessary to determine compliance with City Ordinances. A Permit and inspection are necessary for the initial approval and at each change of tenants. Thereafter each dwelling unit and premises will be inspected every year. You will be contacted in order to schedule an inspection.

This agent is responsible to be the City's contact person for the purposes of scheduling inspections, serving notice, etc.
