

ORDINANCE NO 4, 2020 AS AMENDED

FIXING THE RATE OF COMPENSATION FOR THE MAYOR'S COURT CLERK STARTING FEBRUARY 27, 2020 AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO:

Section 1. That the rate of compensation to be paid to the following full-time employee is fixed as follows:

<u>Mayor's Court Clerk:</u>	<u>BI-WEEKLY</u>	<u>52 WEEKS</u>
First Year	\$1,538.47	\$40,000.00
Second Year	\$1,615.39	\$42,000.00
Third Year	\$1,730.77	\$45,000.00
Fourth Year	\$1,807.70	\$47,000.00
Fifth Year	\$1,884.62	\$49,000.00
Sixth Year	\$2,000.00	\$52,000.00
Seventh Year	\$2,076.93	\$54,000.00
Eighth Year	\$2,153.85	\$56,000.00

Section 2. That the employer may determine the appropriate placement of a new Mayor's Court Clerk hire within the steps established by this ordinance. A new hire placed in a higher step will proceed to the subsequent step on the anniversary date of his or her hire.

Section 3. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is Council's desire that the compensation of the above mentioned personnel be established as soon as possible. Therefore, this Ordinance shall take effect immediately by and upon its passage and the approval of two-thirds of the members of Council. However, this Ordinance shall take effect on the earliest date provided by law if approved by no more than the majority of the members of Council and in that event the emergency provisions herein are set at naught.
