

### REQUIRED SPECS

- 1. Must be single-family residence (no multi-family homes will be considered)
- 2. Setbacks: zoning minimum or 25'
- 3. Must install new curb cut
- 4. Reflect understanding of the aesthetic characteristics of the neighborhood, but at a minimum the exterior materials, facade, and height of home should be similar to surrounding homes.
- 5. Driveway must be no wider than what is required for a single car.
- 6. Preferential consideration will be given to designs with rear or side loading garages.
- 7. Preferential consideration will be given to owner occupant applicants.
- 8. Consolidation of parcels will be financial responsibility of winning bidder

For purposes of this application, if the named applicant is an individual, then "Applicant" shall include the individual as well as any entity within which the applicant is a principal or a majority shareholder; if the Applicant is an entity, then "Applicant" shall include the entity as well as any individual that is a principal or majority shareholder of the entity.

#### Basic Requirements:

- A. Applicant must have the capacity to undertake the redevelopment of the property.
- B. The property must be a vacant, residential lot or a single-family structure.
- C. The Applicant must plan on rehabilitating a single-family structure, newly constructing a single-family home on a residential lot, or incorporating a vacant residential lot into an ongoing or planned single-family home development.
- D. The property must be on the St. Bernard CIC's available properties list, available at <a href="http://www.cityofstbernard.org/services-departments/community-improvement-corporation">http://www.cityofstbernard.org/services-departments/community-improvement-corporation</a>, or the CIC must give the Applicant prior approval of the acquisition of the parcel.

#### General Terms of Sale:

- A. Purchase Price: Pricing varies based on the investment required for the redevelopment, the market value of the property, and the beneficial economic impact of the proposed project.
- B. Redevelopment Terms: All purchasers will be contractually required to develop the proposed project within specific time frames.
- C. Maintenance: The purchaser must maintain the property during the redevelopment.
- D. Property Taxes: The purchaser must agree to pay all property taxes that become due after the transfer in a timely manner.
