It is your responsibility to contact the tax office regarding your case.

WHAT YOU WILL NEED TO FILE YOUR DELINQUENT RETURNS:

- Copy of federal tax return(s) and any federal schedules.
- W2's
- Documents of additional sources of income (proof must be given if it is non-taxable income).

DO NOT COME IN ON THE DAY OF COURT TO DO THIS. YOU WILL NEED TO SUBMIT YOUR TAX DOCUMENTS AT LEAST A WEEK BEFORE YOUR COURT DATE.

IF YOU ARE UNABLE TO PAY YOUR TAX BALANCE IN FULL:

You may be placed on a court monitored payment plan. Sentencing of your case will be on hold until all of your delinquent taxes are paid in full. Interest will be charged.

TAX COURT SCHEDULE OF PAYMENTS ON THE OTHER SIDE



Payments are due by the Friday before the next court date. -PAYMENTS MADE ACCORDING TO THIS SCHEDULE ELIMINATE THE NEED FOR YOU TO APPEAR IN COURT UNTIL YOUR FINAL PAYMENT IS RECEIVED

YOU MUST APPEAR BACK IN COURT AFTER YOUR LAST PAYMENT TO CONCLUDE YOUR CASE.
