**WHAT YOU WILL NEED TO FILE YOUR DELINQUENT RETURNS:**

- Copy of federal tax return(s) and any federal schedules.
- W2's
- Documents of additional sources of income (proof must be given if it is non-taxable income).

**DO NOT COME IN ON THE DAY OF COURT TO DO THIS. YOU WILL NEED TO SUBMIT YOUR TAX DOCUMENTS AT LEAST A WEEK BEFORE YOUR COURT DATE.**

**IF YOU ARE UNABLE TO PAY YOUR TAX BALANCE IN FULL:**

You may be placed on a court monitored payment plan. Sentencing of your case will be on hold until all of your delinquent taxes are paid in full. Interest will be charged.

**\$50.00 MINIMUM PAYMENT PER COURT DATE FOR BALANCES \$500.00 AND UNDER. BALANCES ABOVE \$501.00 WILL BE SUBJECT TO OTHER ARRANGEMENTS.**

**ALL PAYMENT PLANS ARE AT THE DISCRETION OF THE TAX ENFORCEMENT OFFICER.**

**Payments are due by the **Friday** before the next court date.** -PAYMENTS MADE ACCORDING TO THIS SCHEDULE ELIMINATE THE NEED FOR YOU TO APPEAR IN COURT UNTIL YOUR FINAL PAYMENT IS RECEIVED
