 - i. Goals are still to embody the heart of St. Bernard, Maximize density and shepherd the investment into the City
 - ii. Two Buildings, four stories along Vine, mixed use with retail and public green space on the corner of McClelland and Vine
 - iii. One way lane off Vine, in between buildings, and very intentionally does not block visual access to Skyline or Biggby
 - iv. Townhomes back along Andrew that more closely match the character of the homes behind the center.
 - v. Additional green space in the back of the north building.
 - vi. Conscious of parking needs for both proposed development and existing parking.
 - vii. Units 192 units
 - viii. 172,000 sq ft of development
 - ix. Timeline, total about 24-28 months.
 - 1. 4-6 weeks design will be final
 - 2. +4-6 months demolition complete/ site work complete
 - 3. +3-4 months building construction begins
 - 4. +16-18 months project complete
