Treasurer's Report

5/3: \$367,423.00 (includes the payment of first half property taxes and damage cleanup to First State Bank)

First State Bank - \$50,510.06

Water Bill for FSB damage was presented and will be paid.

Action Items:

- 1. Mowing Contract for CIC Properties received a single bid. Same vendor who did the work last year (Josh Schueler/ JMS Landscaping). He submitted a bid of \$550/10 day mowing cycle.
 - a. CIC may explore the option of a Holding Agreement with the Port Authority to manage costs of maintenance in the future
 - b. Motion to accept the bid as submitted made by Joe Brickler, seconded by Tom Rolfsen, all in favor.
- 2. First State Bank Building
 - a. Water Damage \$7,820.50 for repair and remediation to the building
 - b. Payment of Water Bill for First State Bank Bill is for water charges and sewer charges is \$3,106.27. Bob Culbertson intends to speak with Water Works and negotiate the sewer charges.
 - i. First State Bank will reimburse us for their normal water bill of \$204.07
 - c. Sale of Items from Loan Center
 - i. First State Bank appears to have no intention of collecting the items in the Loan Center, which Jonathan Stuchell will confirm with FSB, but the CIC will explore the option of selling the items.
 - ii. There were also proprietary files left in the Loan Center as well, FSB indicated they were planning to collect them.
