- 2. Old Police Station Update
 - a. Recent showing of the building to an Art Academy. Tom Paul did not obtain contact information.
 - b. Amy Yosmali believes it may be the Clifton Community Arts Center (CCAC) which recently lost its location up on Clifton Avenue and needs to vacate by September 2019. Amy Yosmali was to reach out and confirm.

- c. The building is not move in ready
- d. We should consider temporary uses the Eagles are looking for a new space, but no formal request has been made.
- e. The building still needs to be shown to the vet who applied for 4509 Vine Street.
- 3. 4509 Vine Street Update
 - a. Recent showing to a local business
 - b. Possible consideration of white box interior property has dilapidated considerably since CIC first took ownership. There are issues with the stairwell, false wall, carpeting, and bubbling plaster.
