## Meeting Minutes

- **Previous meeting minutes:** Reviewed and confirmed correct; motion to accept by Joe Brickler, seconded by Amy Yosmali, and carried.

## Treasurer's Report

- **Account balances:**
  - Fifth account: \$134,694.86
  - First State account: \$5,328.87
- **Discussion:** Consideration to close the First State account and combine funds for efficiency; action pending logistics.

## Action Items & Property Sale

- **Recent sale:** 306 Bank Avenue sold for \$5,000.

- The property (a side lot) will be consolidated with an adjoining property, benefiting the new owner and reducing CIC maintenance costs.
- **Board expressed gratitude** for the sale and its positive impact.

## Executive Session

- **Purpose:** Discuss sale of property.
- **Motion:** Enter executive session (motion by Amy Yosmali, seconded by Joe Brickler); approved by roll call.
- **Return:** Motion to exit executive session (by Joe Brickler, seconded by Amy Yosmali); approved.

---

## Contract with Civitas Development

- **Motion:** Terminate contract with Civitas Development (motion by Jeff Edwards, seconded by Tom Rolfsen); CIC board unanimously approved.
- **Official statement:**
  - Regret over the partnership ending, but optimism for future redevelopment of the shopping center.
  - CIC's focus remains on high-quality, community-aligned redevelopment.
  - Beginning next month, alternative options for redevelopment will be explored.

## Board Member Terms & Elections

- **Upcoming cycles:**
  - For 2025: Jonathan Stutrell, Tom Rolfsen, and Joe Brickler are up for cycling out or re-election.
  - For 2026: Chris Sauer, Chris Schildmeyer and Ali Palmer
- **Plan:**
  - Formalize and advertise openings for the January meeting.
  - Seek to avoid term overlap and ensure orderly transitions.

## **Other Business & Next Meeting**

- **Treasurer transition:** Bob Culbertson, Jonathan Stuchell and Chris Schildmeyer to collaborate on transition of Treasurer position.
- **December 2025 meeting:**
  - Likely to be canceled due to holidays unless urgent business arises.
  - January meeting will be used for elections and any pressing issues.
