Mr. Stegman - The Chief came to me to enter into a contract for the new ambulance. I asked him if anyone had appropriated the money for it. So in the one Ordinance that we passed it gave the amount but it didn't give it to appropriate to the Police and Fire to enter into the contract so that's what that is being asked for tonight, for that \$199,000.00 and then there is some ladder work that, on the aerial truck, they needed extra money to fix.

Ms. Hausfeld - inaudible.

Mr. Stegman - That I'm not going to be able to answer to you.

Mr. Tobergte - I haven't talked to the Chief, I'm assuming since he's down two men he's moving money over, from the line item because the over time that was caused by being short two men.
