## **INAUGURAL CEREMONY**

## December 1<sup>st</sup>, 2023

The St. Bernard Village Inaugural Ceremony was held on December 1st, 2023, in Council Chambers.

The meeting was opened with the Pledge of Allegiance and a prayer from Father EJ Stein.

Roll call showed six members were present: Mr. Moreton, Mr. Stuchell, Mr. Edwards, Ms. Hausfeld, Mr. Culbertson, and Mr. Estep. Absent: Mr. Schildmeyer.

Mayor, Mr. Stuchell- Thank you, Mr. President. Welcome and congratulations to our new council members and welcome back to our senior members as well. Never in a million years did I see myself in this seat, and I couldn't be prouder to continue to serve as your mayor. But most of all, I can't believe that I'm actually sitting here looking up at my son Gus, who's getting ready to be sworn in as a member of council. So, it's going to be different, especially when anyone says Mr. Stuchell. So, this evening I'd like to introduce Judge Mike Peck, our former Law Director and President of the Council. Now you have some new folks up here and it is fun to see Gus Stuchell taking the seat at council and now you don't have to call him dad. You can call him, you know, mayor or Mr. Stuchell, and he's got to call you Councilman. I see Mr. Edwards, who I've known for a long time take his chair and I know he'll serve Saint Bernard very well. We have a new face also, Mr. Morton and you're a brand-new member of council. You served anywhere else? No. How old are you, Sir?

President of Council, Mr. Asbach- I am starting my 37th year.

<u>Judge</u>, <u>Mike Peck-</u> Alright, congratulations! I just want to thank you for having me back here to swear in the elected officials. I greatly appreciate it. St. Bernard is a very special place for me and my family, and it always will be. Ok, if council will please stand.

Motion made by Ms. Hausfeld, seconded by Mr. Estep, to elect Mr. Chris Schildmeyer as President of Council Pro Temp. Motion passes 6-0.

Council member, Mr. Culbertson nominates Ms. Caroline Stegman for Clerk of Council Pro Temp, seconded by Mr. Estep. Motion passes 6-0.

Motion made by Mr. Edwards, seconded by Mr. Stuchell, to close nominations. Motion passes 6-0.

Motion made by Ms. Hausfeld, seconded by Mr. Moreton, to elect Ms. Caroline Stegman as Clerk of Council Pro Temp. Motion passes 6-0.

Judge, Mike Peck- Now, if I could have the Mayor and the Clerk of Council please stand.

The Mayor and Clerk of Council stand to be sworn in. Each person raises right hand and states their name stating the follow:

"I do solemnly swear to support the Constitution of the United States and the Constitution of the State of Ohio, in the Statutes and Rules of the Village of Saint Bernard and faithfully discharge the duties as an elected position for which I was elected, so help me God."

<u>Judge, Mike Peck-</u> Congratulations!

Audience applauds.

<u>President of Council, Mr. Asbach-</u> Thank you, judge. At this time, I will turn things over to the mayor, Mr. Stuchell.

Mayor, Mr. Stuchell- Thank you. This evening, we will be appointing Director of Safety and Service, Tom Paul, Tax Administrator Leighanne Helmes, Recreation Director Paul Schildmeyer, our assistant directors, Kim Martin, Jeff Stegman, Chris Sauer and Jennifer Johnson, Mayor's Assistant, Cheryl Abrams and of course Sharon McCullough.

All members of the administration stand to be sworn in. Each member raises right hand and states their name stating the follow:

"I do solemnly swear to support the Constitution of the United States and the Constitution of the State of Ohio, in the Statutes and Rules of the Village of Saint Bernard and faithfully discharge the duties as an elected member of this council, so help me God."
