## **ORDINANCE NO. 14, 2022**

## AMENDING ORDINANCE 9, 2022, COMPENSATION OF SERVICE DEPARTMENT PART TIME LABORER POSITION SECTION, AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the Village of St. Bernard established a new pay structure for certain part-time employees to include different rates over certain time intervals; and

WHEREAS, this new pay structure is to be effective for those employees whose first date of service in the position is on or after 1/1/2005; now therefore

## BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO:

<u>Section 1.</u> Part Time Service Department Laborers three year pay steps shall be amended and enacted as follows and shall be effective May 12, 2022.

Service Department Laborers now reads:

## Service Department Laborers shall be amended to read as follows:

Section 2: This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is Council's desire that the compensation of the above mentioned personnel be amended as soon as possible to aid with hiring Service Department, Part Time Laborers. Therefore, this Ordinance shall take effect immediately by and upon its passage and the approval of two-thirds of the members of Council. However, this Ordinance shall take effect on the earliest date provided by law if approved by no more than the majority of the members of Council and in that event the emergency provisions herein are set at naught.
