ORDINANCE NO 22, 2023

FIXING THE COMPENSATION AND PROVIDING FOR ANNUAL PERCENTAGE INCREASES FOR THE POSITIONS OF AUDITOR, TAX ADMINISTRATOR, AND SAFETY/SERVICE DIRECTOR OF THE VILLAGE OF ST. BERNARD AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO:

Section 1. That the rate of compensation to be paid to the following elected/appointed employees on the listed dates and will include annual percentage increases based on the average percentage of the collective bargaining units of the Fire, Police, and Service Departments. A range of compensation may be established for certain appointed positions based on their level of experience at the time of appointment. Average annual increase to take effect 111 2025

Starting-

<u>Section 2.</u> This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is that the above funds are needed to be available for payment of expenses not provided for previously. Therefore, this Ordinance shall take effect immediately by and upon its passage, and the approval of two-thirds of the members of said Council. However, this Ordinance shall take effect on the earliest date provided by law if approved by no more than the majority of members of Council, and in that event, the emergency provisions herein are set at naught.
