

ORDINANCE NO. 5, 2021

FIXING THE COMPENSATION OF THE DIAL A RIDE PART-TIME EMPLOYEES OF THE VILLAGE OF ST. BERNARD WHOSE FIRST DATE OF SERVICE IN THE POSITION IS AFTER 12/1/2012, AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the Village of St. Bernard established a new pay structure for Dial A Ride part-time employees to include different rates over certain time intervals; and

WHEREAS, this new pay structure is to be effective for those employees whose first date of service in the position is on or after 12/1/2012; now therefore

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO:

Section 1. That the rate of compensation to be paid to the Dial A Ride part-time employees is fixed as follows, unless Federal or State law requires otherwise:

Section 2. This Ordinance will remove Section 159.18 of Ordinance 25, 2000, establishing additional benefits for certain permanent part-time employees for any Dial A Ride part-time employees hired after 12/1/2012.

This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is Council's desire that the compensation of the above mentioned personnel be established as soon as possible. Therefore, this Ordinance shall take effect immediately by and upon its passage and the approval of two-thirds of the members of Council. However, this Ordinance shall take effect on the earliest date provided by law if approved by no more than the majority of the members of Council and in that event the emergency provisions herein are set at naught.
