AMENDING CERTAIN SECTIONS IN CHAPTER 121 OF ST. BERNARD'S CODIFIED ORDINANCES AND DECLARING AN EMERGENCY.

WHEREAS, the Council of St. Bernard intends to amend sections 121.10(a)(2), and 121.10(i)(2), in order to update the protocol, policy and procedures of the St. Bernard Council; now therefore

BE IT ORDAINED BY THE COUNCIL OF ST. BERNARD, STATE OF OHIO:

Section 1. That section 121.10(a)(2) of the codified ordinances which now reads:

121.10 (a) Council Meeting.

(2) Regular meeting of Council shall be held on the second Thursday of the month, commencing promptly at 7:00 p.m. If any first Thursday falls on a holiday, then the regular meeting shall be held the preceding or following Tuesday evening at 7:00 p.m. or such date as Council may agree upon by majority vote.

is hereby amended to read as follows:

121.10 (a) Council Meeting.

(2) Regular meeting of Council shall be held on the fourth Thursday of the month, commencing promptly at 7:00 p.m. If any fourth Thursday falls on a holiday, then the regular meeting shall be held the preceding or following Tuesday evening at 7:00 p.m. or such date as Council may agree upon by majority vote.

Section 2. That section 121.10(i)(2) of the codified ordinances which now reads:

121.10 (i) Committee of the Whole

(2) Regular Committee of the Whole meetings shall be held on the fourth Thursday of the month, commencing promptly at 7:00 p.m.

is hereby amended to read as follows:

121.10 (i) Committee of the Whole

(2) Regular Committee of the Whole meetings shall be held on the second Thursday of the month, commencing promptly at 7:00 p.m. If any second Thursday falls on a holiday, then the regular meeting shall be held the preceding or following Tuesday evening at 7:00 p.m. or such date as Council may agree upon by majority vote.

Section 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is the immediate need to update the Codified Ordinances of St. Bernard. Therefore, this Ordinance shall take effect immediately by and upon its passage, and the approval of two-thirds of the members of said Council. However, this Ordinance shall take effect on the

earliest date provided by law if approved by no more than a majority of the members of Council and in that event the emergency provisions herein are set at naught.
