ORDINANCE NO. 08, 2017

AN ORDINANCE AUTHORIZING THE SERVICE DIRECTOR TO ADVERTISE FOR BIDS AND TO ENTER INTO A PROPER CONTRACT FOR THE MOELLER AVENUE IMPROVEMENT PROJECT AND DECLARING AN EMERGENCY

WHEREAS, the Village wishes to advertise for bids and enter into contract with the lowest responsible bidder for the Moeller Avenue Improvement project; now therefore

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO:

Section 1. The Service Director is hereby authorized and directed to advertise for bids for the Moeller Avenue Improvement project.

<u>Section 2.</u> That the Service Director is hereby authorized and directed to take all necessary actions for the negotiation and execution of a contract with the lowest and best bidder for the Moeller Avenue Improvement project.

Section 3. Each bid shall be in conformity with the specifications on file in the office of the Service Director and shall be received on a day certain to be determined by said Director. Each bid shall contain the full name of the person or company interested therein and the right shall be reserved to reject any and all bids.

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is to enter into this contract as soon as possible to complete the Moeller Avenue Improvement project. Therefore, this Ordinance shall take effect immediately by and upon its passage, and the approval of two-thirds of the members of said Council. However, this Ordinance shall take effect on the earliest date provided by law if approved by no more than a majority of the members of Council and in that event the emergency provisions herein are set at naught.
