

ORDINANCE NO. 8, 2021

AUTHORIZING AND DIRECTING THE AUDITOR TO CREATE A NEW CASH FUND AND NEW LINE ITEM, TRANSFER FUNDS, MOVE APPROPRIATIONS AND PROVIDE ADDITIONAL APPROPRIATIONS AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO:

Section 1. That the Auditor is hereby authorized and directed to create a new Cash Fund and New Line Item:

50-1000 Employee Accumulated Sick Time Cash Fund

50-01 Employee Accumulated Sick Time Expenses

Section 2. That the Auditor is hereby authorized and directed to transfer the following \$652,219.98

FROM GENERAL FUND

01-5-A-19 General Fund Transfer Out \$652,219.98

TO CASH ACCOUNTS:

07-1000 Capital Improvements Cash Account \$500,000.00

50-1000 Employee Accumulated Sick Time Cash Act. \$152,219.98

Section 3. That the Auditor is hereby authorized and directed to move the following appropriations:

FROM: 01-67 Employee Accumulated Sick Time \$12,219.98

TO: 50-01 Employee Accumulated Sick Time \$12,219.98

Section 4. That the Auditor is hereby authorized and directed to provide additional appropriations to the following:

50-01 Employee Accumulated Sick Time \$40,000.00

Section 5. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is that the above funds are needed to be available for payment of expenses not provided for previously. Therefore, this Ordinance shall take effect immediately by and upon its passage, and the approval of two-thirds of the members of said Council. However, this Ordinance shall take effect on the earliest date provided by law if approved by no more than the majority of members of Council, and in that event, the emergency provisions herein are set at naught.
