

ORDINANCE NO. 18, 2019

AMENDING THE ST. BERNARD CODIFIED ORDINANCES SECTION 141.05 AND 143.03, ESTABLISHING THE MAXIMUM AGE LIMITATIONS FOR APPOINTMENT WITH THE ST. BERNARD POLICE AND FIRE DEPARTMENTS, AND DECLARING AN EMERGENCY

WHEREAS, the Village Council for the Village of St. Bernard intends to amend certain sections of the St. Bernard Codified Ordinances and establish a new maximum age limitation for the St. Bernard Fire Department; now therefore

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO:

Section 1. Section 141.05 of the St. Bernard Codified Ordinances which reads as follows:

(a) Pursuant to Ohio R.C. 124.41 and 124.42, the Village of St. Bernard, by and through its Council, hereby establishes the maximum age limitation of forty years of age for an original appointment or forty years of age for an original appointment to a previous department for lateral transfers to the St. Bernard Police Department and the maximum age limitation of thirty-six years of age for an original appointment or thirty-six years of age for an original appointment to a previous department for lateral transfers to the St. Bernard Fire Department.

(b) All other requirements for original appointment to either the St. Bernard Police Department or the St. Bernard Fire Department, as set forth under Ohio law or the Codified Ordinances, shall remain the same.

Shall be amended to read as follows:

(a) Pursuant to Ohio R.C. 124.41 and 124.42, the Village of St. Bernard, by and through its Council, hereby establishes that no person is eligible to receive an original appointment to the St. Bernard Police Department, or to a previous department for lateral transfers to the St. Bernard Police Department, on or after the person's forty-first birthday.

(b) All other requirements for original appointment to the St. Bernard Police Department as set forth under Ohio law or the Codified Ordinances, shall remain the same.

Section 2. Section 143.03 of the St. Bernard Codified Ordinances which reads as follows:

(a) Pursuant to Ohio R.C. 124.42, Council hereby establishes the maximum age limitation of thirty-six years of age for an original appointment to the St. Bernard Fire Department.

(b) No person is eligible to receive an original appointment to the St. Bernard Fire Department on and after their thirty-sixth birthday.

(c) All other requirements for original appointment to the St. Bernard Fire Department, as set forth under Ohio law or the St. Bernard Codified Ordinances, shall remain the same.

Shall be amended to read as follows:


(a) Pursuant to Ohio R.C. 124.41 and 124.42, the Village of St. Bernard, by and through its Council, hereby establishes that no person is eligible to receive an original appointment to the St. Bernard Fire Department, or to a previous department for lateral transfers to the St. Bernard Fire Department, on or after the person's forty-first birthday.

(b) All other requirements for original appointment to the St. Bernard Fire Department, as set forth under Ohio law or the Codified Ordinances, shall remain the same.

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is the immediate need to update the Codified Ordinances of the Village of St. Bernard. Therefore, this Ordinance shall take effect immediately by and upon its passage, and the approval of two-thirds of the members of said Council. However, this Ordinance shall take effect on the earliest date provided by law if approved by no more than a majority of the members of Council and in that event the emergency provisions herein are set at naught.




