AN ORDINANCE AMENDING SECTION 121.10(a)(3) OF THE CODIFIED ORDINANCES OF THE VILLAGE OF ST. BERNARD, OHIO AND DECLARING AN EMERGENCY

WHEREAS, the Council of the Village of St. Bernard, Hamilton County, Ohio, is adopting Resolution 4, 2022, to establish, "by rule," a reasonable method for giving notice of meetings of Council's regular, special, and emergency Council meetings in accordance with Ohio's public meetings law, and

WHEREAS, Council wishes to amend Section 121.10(A)(3) of the Codified Ordinances of the Village of St. Bernard to comport with that Rule; now therefore

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO:

Section 1. Section 121.10(a)(3) of the Codified Ordinances of The Village Of St. Bernard shall be amended to read:

(3) Special meetings of Council may be called by the Mayor in the manner prescribed in Ohio R.C. 731.46 or by any three members of Council. Special meetings may be called by giving at least twenty-four (24) hours' notice except in the event of an emergency requiring immediate official action.

Notice to each member of Council shall be served personally or left at his or her usual place of residence by the Clerk of Council or a police officer.

Section 2. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety. The reason for the emergency is the need to bring the Codified Ordinance into alignment with Ohio's public meeting law. Therefore, this Ordinance shall take effect immediately by and upon its passage, and the approval of two-thirds of the members of said Council. However, this Ordinance shall take effect on the earliest date provided by law if approved by no more than a majority of the members of Council and in that event the emergency provisions herein are set at naught.
