

**ORDINANCE NO. 30, 2023**

**AN ORDINANCE AMENDING SECTION 123.01(b) OF THE  
CODIFIED ORDINANCES OF THE VILLAGE OF ST.  
BERNARD, OHIO AND DECLARING AN EMERGENCY**

**WHEREAS**, the Council of the Village of St. Bernard, intends to amend certain sections of the St. Bernard Codified Ordinances by adding additional locations for posting of ordinances to increase visibility for the St. Bernard residents; now therefore:

**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO:**

**Section 1.** Section 123.01(b) of the Codified Ordinances of The Village of St. Bernard shall be amended to read:

(b) The following places or locations in the Village are designated as the most public places or locations in the Village of the posting of ordinances, resolutions, statements, orders, proclamations, notices, and reports required by law or ordinance to be published:

- (1) the covered display case on the exterior wall near the main entrance at City Hall at Vine and Washington Avenue,
- (2) display case inside the Safety Center lobby,
- (3) display case at the park on Bertus Street,
- (4) display case at the park on Heger Drive,
- (5) display case at the park on Greenlee Ave.

**Section 2.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety. The reason for the emergency is the need to comport with applicable law. Therefore, this Ordinance shall take effect immediately by and upon its passage, and the approval of two-thirds of the members of said Council. However, this Ordinance shall take effect on the earliest date provided by law if approved by no more than a majority of the members of Council and in that event the emergency provisions herein are set at naught.
