

**ORDINANCE NO. 36, 2023**

**AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF ST. BERNARD, OHIO, REVISING THE TRAFFIC AND GENERAL OFFENSES CODES TO COMPLY WITH STATE LAW, AND DECLARING AN EMERGENCY**

**WHEREAS,** various ordinances of a general and permanent nature have been passed, which should be included in the Codified Ordinances of St. Bernard, Ohio; and

**WHEREAS,** there have been numerous statutes passed since the last codification which should be reflected in the Traffic, and General Offenses Codes in the Codified Ordinances; now therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO:**

**Section 1.** That the editing, arrangement and numbering of those ordinances and resolutions enacted by Council from 04/01/2023 to 10/01/2023, as listed in the Comparative Section Table, are hereby approved and adopted as printed in the October 2023 Replacement Pages to the Codified Ordinances so as to achieve uniformity of style and classification. A copy of such Replacement Pages is attached to this ordinance and incorporated as a part hereof.

**Section 2.** That the following sections of the Codified Ordinances enacted, amended or repealed in the manner respectively indicated in order to comply with current State law:

**Section 3.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is the immediate need to update the Codified Ordinances of St. Bernard. Therefore, this Ordinance shall take effect immediately by and upon its passage, and the approval of two-thirds of the members of said Council. However, this Ordinance shall take effect on the earliest date provided by law if approved by no more than a majority of the members of Council and in that event the emergency provisions herein are set at naught.
