

**RESOLUTION NO. 03, 2021**

**AN RESOLUTION AUTHORIZING THE VILLAGE OF ST. BERNARD TO PREPARE AND SUBMIT APPLICATIONS TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND/OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S) AND TO EXECUTE CONTRACTS AS REQUIRED, AND DECLARE AN EMERGENCY**

**WHEREAS**, on 17 December 2020, the Village of St. Bernard passed Resolution No. 11, 2020, which authorized the Mayor to apply for financial assistance from the State Capital Improvement Program ("SCIP") and/or Local Transportation Improvement Program(s) for the construction of capital improvements to public infrastructure and authorized the Mayor to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance; and

**WHEREAS**, heretofore, the Village of St. Bernard has applied for grants from SCIP and/or the Local Transportation Improvement Program(s); and

**WHEREAS**, the Village of St. Bernard is planning to make capital improvements to various streets and infrastructure in need of repair; and

**WHEREAS**, the Village of St. Bernard seeks to include the ability to apply for loans and grant loans from SCIP and/or the Local Transportation Improvement Program(s); and

**WHEREAS**, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the OPWC programs; now therefore

**BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, STATE OF OHIO**

**Section 1.** The Mayor is hereby authorized to apply to the OPWC for funds as described above.


**Section 2.** The Mayor is authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

**Section 3.** This resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety. The reason for the emergency is the time frame for the application to be submitted. Therefore, this resolution shall take effect immediately by and upon its passage, and the approval of two-thirds of the members of said Council. However, this resolution shall take effect on the earliest date provided by law if approved by no more than the majority of the members of Council and in that event the emergency provisions herein are set at naught.
