## **RESOLUTION NO. 06, 2021**

## AN RESOLUTION SUPPORTING AN INCLUSIVE ST. BERNARD AND A BIPARTISAN OHIO FAIRNESS ACT, AND DECLARING AN EMERGENCY

**WHEREAS,** individuals who are lesbian, gay, bisexual, transgender, and queer (LGBTQ) include individuals from all faiths, races, national origins, socioeconomic statuses, education levels, and political beliefs; and

**WHEREAS,** LGBTQ people in the United States have made, and continue to make vital contributions to the United States and to the world in every aspect, including in the fields of education, law, business, science, research, economic development, architecture, law enforcement, healthcare, fashion, sports, government, military, music, film, politics, technology, literature, and civil rights; and

**WHEREAS,** on June 26, 2015, the Supreme Court of the United States ruled in Obergefell v. Hodges, 135 S. Ct. 2584, that same-sex couples have a constitutional right to marry and acknowledged that "no union is more profound than marriage, for it embodies the highest ideals of love, fidelity, devotion, sacrifice, and family."; and

WHEREAS, the Ohio Senate and House of Representatives are currently considering the Ohio Fairness Act (SB119, HB208); and

**WHEREAS,** this legislation amends Ohio's anti-discrimination laws to include sexual orientation, gender identity, and gender expression as protected classes, expanding legal protections in housing, employment, and access to public accommodations; and

**WHEREAS**, the Ohio Fairness Act would empower all Ohio residents to more fully contribute in the workplace, engage in commerce, and participate in civic life without fear of discrimination; and

**WHEREAS,** Nearly three quarters of Ohioans favor employment and housing laws that make it illegal to discriminate based on sexual orientation or gender identity, and of the state's top 98 employers, over 80 have nondiscrimination policies; now therefore

## BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF ST. BERNARD, HAMILTON COUNTY, OHIO:

**SECTION 1:** That the Village of St. Bernard strongly supports an Ohio Fairness Act and urges members of the Ohio Legislature to act with fairness and justice in ensuring that all Ohioans enjoy freedom from discrimination.

**SECTION 2:** That the Clerk of Council is hereby directed to send a copy of this Resolution to Ohio House Speaker Robert E. Cupp, Ohio Senate President Matt Huffman, House Commerce and Labor Committee Chair Dick Stein, Senate Government Oversight and Reform Committee Chair Kristina D. Roegner, Representative Mark Johnson, Senator Rob McColley, Representative Brigid Kelly, Senator Cecil Thomas, and to all members of the Ohio House Commerce and Labor Committee and Ohio Senate Government Oversight and Reform Committee.
